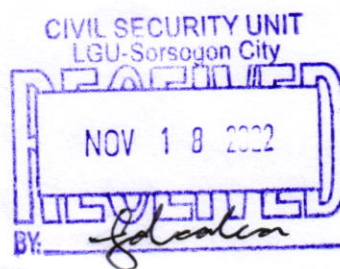
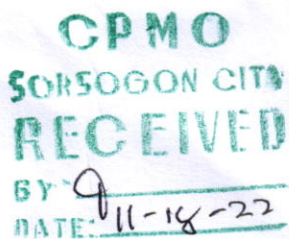

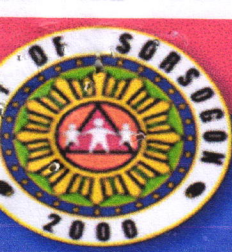

THIS AGREEMENT made this **11th** day of **November**, **2022** between **Ma. Ester E. 




