

CONTRACT AGREEMENT

THIS AGREEMENT made this 13th day of January, 2023 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and JOSE BONIFACIO L. LASALA proprietor of JL ENTERPRISES (hereinafter called the "Supplier") of the other part:
