## **CONTRACT AGREEMENT**

THIS AGREEMENT made this 19th day of August , 2022 between Ma. Ester E. Hamor, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and ALBERT Y. LUSTESTICA Proprietor of ALHADRAX CONTRUCTION & SUPPLY ( hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz REPAIR/REHAB. OF SEAWALL @ POBLACION BACON during the State of Health Emergency and has accepted a Bid by the Supplier for the supply of those goods and services in the sum Six Hundred Ninety Eight Thousand Seven Hundred Ninety Pesos (P 698,790.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

In consideration for the sum of Six Hundred Ninety Eight Thousand Seven Hundred Ninety Pesos (P 698,790.00) or such other sums as may be ascertained, ALHADRAX CONTRUCTION & SUPPLY agrees to viz REPAIR /REHAB. OF SEAWALL @ POBLACION BACON in accordance with his/her/its Bid. 4. The <u>City Government of Sorsogon</u> agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
