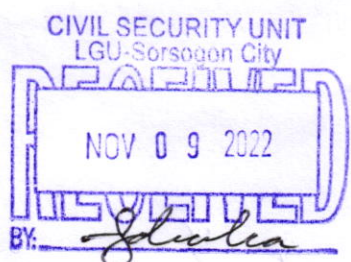
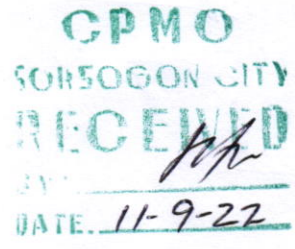
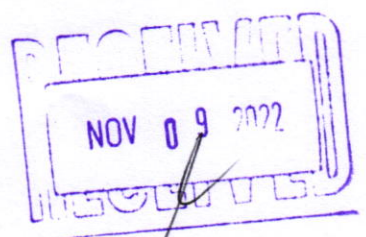

CONTRACT AGREEMENT

THIS AGREEMENT made this **5th** day of **November**, **2021** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the “ Entity”) of the one part and **DENNIS B. 
