

CONTRACT AGREEMENT

THIS AGREEMENT made this <u>16th</u> day of **December**, 2022 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the "Entity") of the one part and Engr. DAVID E. DE GUZMAN proprietor of D. E. DE GUZMAN SURVEYING (hereinafter called the "Supplier") of the other part:

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Berformance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

CONCINENTS OF SOCION CITY CONCINENTS OF SOCION CITY Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
