CONTRACT AGREEMENT

THIS AGREEMENT made this 16th day of **December**, 2022 between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and **ABELARDO A.
