





CONTRACT AGREEMENT

THIS AGREEMENT made this **16th** day of **December**, **2022** between **Ma. Ester E. Hamor**, **City Mayor, City of Sorsogon** Philippines (hereinafter called the “ Entity”) of the one part and **LEO H.
