#### CONTRACT AGREEMENT

THIS AGREEMENT made this 16th day of **December**, 2022 between **Ma. Ester E. Hamor**, **City Mayor**, **City of Sorsogon** Philippines (hereinafter called the "Entity") of the one part and LEO **H. HILIS** Proprietor of **RBMPRO ELITE SOUND SYSTEM RENTAL** (hereinafter called the "Supplier") of the other part:
