



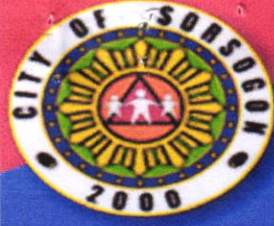

CONTRACT AGREEMENT
