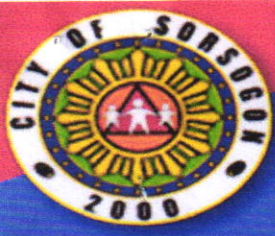

CONTRACT AGREEMENT

THIS AGREEMENT made this **13th** day of **January, 2023** between **Ma. Ester E. Hamor**, City Mayor, City of Sorsogon Philippines (hereinafter called the " Entity") of the one part and **MILAGROS D. LIAO** Proprietor **BIG B ENTERPRISES** (hereinafter called the "Supplier") of the other part:

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz **SUPPLY & DELIVERY OF VARIOUS DISPOSABLES FOR USE DURING GROUPIE PAYOUT** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum **Six Hundred Sixty Thousand Four Hundred Fifty Pesos (₱ 660,450.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

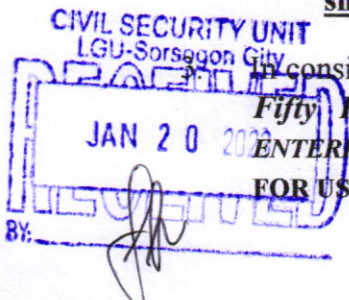
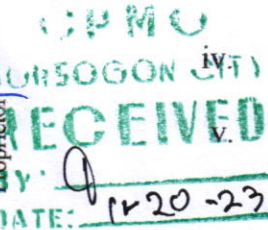
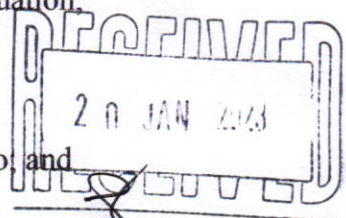

In consideration for the sum of **Six Hundred Sixty Thousand Four Hundred Fifty Pesos (₱ 660,450.00)** or such other sums as may be ascertained, **BIG B ENTERPRISES** agrees to viz **SUPPLY & DELIVERY OF VARIOUS DISPOSABLES FOR USE DURING GROUPIE PAYOUT** in accordance with his/her/its Bid.




