**RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF TWO (2) COCK DERBY ON MARCH 12, 2022 SPONSORED BY THE NATIONAL BREEDER'S AND COCKER'S LEAGUE BAGWIS NATIONAL AT SORSOGON COCKPIT COLISEUM, BRGY. BIBINCAHAN, EAST DISTRICT, SORSOGON CITY**

**WHEREAS**, among the items deliberated during the March 8, 2022 Regular Session of the 7th City Council was the Letter from Aladin Caubang, Sorsogon Coordinator, Bagwis National informing the body of his inadvertence on the request for derby which was supposedly two (2) Cock instead of seven (7) stag derby scheduled on March 12, 2022 at Sorsogon Cockpit Coliseum, Brgy. Bibincahan, East District, Sorsogon City approved by the 7<sup>th</sup> City Council on its February 22, 2022 Regular Session under Resolution No. 073, Series of 2022;

**WHEREAS**, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement

through the owner of the cockpit and shall be given to the respective requesting party and that the party shall faithfully comply therewith;

**WHEREAS**, pursuant to Inter Agency Task Force on Covid19 (IATF) Resolution No. 154, Series of 2021 and to the existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the City;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution approving and authorizing the conduct of two (2) cock derby on March 12, 2022 at Sorsogon Cockpit Coliseum, Brgy. Bibincahan, East District, Sorsogon City;

**NOW THEREFORE**, on motion of **Hon. Danilo A. Deladia**, duly seconded by **Hon. Rebecca D. Aquino**, resolved as it is hereby resolve to approve and authorize the conduct of two (2) derby on March 12, 2022 at Sorsogon Cockpit Coliseum, Brgy. Bibincahan, East District, Sorsogon City;

**RESOLVED FURTHER**, that fees and charges appurtenant thereto shall be paid to the City Treasurer's Office prior to the conduct of the activity;

**RESOLVED FINALLY**, that copies of this resolution be furnished to all concerned for their information and guidance.
