RESOLUTION EXPRESSING GRATITUDE TO ATTY. MARTIN B. DELGRA III, REB REA ENP, CHAIRMAN, LAND TRANSPORTATION FRANCHISING REGULATORY BOARD (LTFRB) FOR IMMEDIATE AND POSITIVE RESPONSE IN RELATION TO THE APPEAL OF THE 7TH CITY COUNCIL FOR EXTENSION OF CONSOLIDATION OF PUBLIC UTILITY JEEPNEYS (PUJ'S) IN THE PUBLIC UTILITY VEHICLE MODERNIZATION PROGRAM (PUMP).

WHEREAS, on January 04, 2022, the 7th City Council passed and approved Resolution No. 012, series of 2022 entitled "Resolution Reiterating the Request of the Sangguniang Panlungsod addressed to Atty. Martin B. Delgra, III, Chairman, Land Transportation Franchising Board (LTFRB), Strongly Appealing the Extension of Consolidation of Public Utility Jeepneys (PUJ's) in the Public Utility Vehicle Modernization Program (PUVMP);

WHEREAS, in a letter dated February 10, 2022, Atty. Martin B. Delgra, he mentioned Memorandum Circular No. 2021-077 dated December 15, 2021 which opened the acceptance of Application for Consolidation effective December 20, 2021 until March 31, 2022 covering routes without applicant or filed application with the LTFRB Central Office and Regional Franchising Regulatory Offices as of March 31, 2021, but only for the following applicants;

1. Those who have consolidated into a legal entity, either as Corporation or Cooperative upon the effectivity of MC 2021-077; and
2. Those with filed and pending application for Registration/Accreditation with proper agencies (i.e. Securities and Exchange Commission-for Corporation or Cooperative of the Philippines and Office of the Transport Cooperatives-for Cooperatives) prior to the effectivity of MC 2021-077.

WHEREAS, also stated therein that Application for Consolidation shall only be accepted by the LTFRB if the Applicant is already registered as a legal entity and the same is filed not later than March 31, 2022 and applicant not falling under the above categories, particularly those who are yet to consolidate into a legal entity, are deemed excluded in the coverage of MC 2021-077;

WHEREAS, further, notwithstanding the above policy of the Board, aforementioned Resolution No. 12, series of 2022 of the 7th City Council has been forwarded to the Office of the Executive Director to be included in the agenda for discussion during the next Board Meeting;

WHEREAS, foregoing premises considered, the 7th City council deemed it necessary to pass a resolution expressing gratitude to Atty. Martin B. Delgra III, REB REA EnP, Chairman, Land Transportation Franchising Regulatory Board for immediate and positive response in relation to the appeal of the 7th City Council for Extension of Consolidation of Public Utility Jeepneys (PUJ's) in the Public Utility Vehicle Modernization Program (PUMP);

NOW THEREFORE, on incidental motion of the **Hon. Franco Eric O. Ravanilla**, duly seconded by **Hon. Rebecca D. Aquino**, resolve as it is hereby resolved to express gratitude to Atty. Martin B. Delgra III, REB REA EnP, Chairman, Land Transportation Franchising Regulatory Board for immediate and positive response in relation to the appeal of the 7th City Council for Extension of Consolidation of Public Utility Jeepneys (PUJ's) in the Public Utility Vehicle Modernization Program (PUMP);
