RESOLUTION ENACTING AN ORDINANCE REALIGNING THE AMOUNT OF ELEVEN MILLION SIX HUNDRED EIGHT THOUSAND NINE HUNDRED THIRTY THREE AND 60/100 (P11,608, 933.60) PESOS FROM HEREUNDER SOURCE OF FUNDS AND DESTINATION OF FUNDS OF VARIOUS OFFICES OF THE CITY GOVERNMENT OF SORSOGON.

WHEREAS, Section 336 of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that the Local Chief Executive or the Presiding Officer of the Sanggunian concerned may by an ordinance authorize the augmentation of any item in the approved annual budget for offices from savings in other items within the same expense class of their respective appropriations;

WHEREAS, in order to pursue the mandate given to the said office specifically the need to address social and legislative services, sufficient funds for the purpose is indispensable;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to approve the same;

NOW THEREFORE, on incidental motion of **Hon. Franco Eric O. Ravanilla**, duly seconded by the **Hon. Joven Francis J. Laura**, the 7th City Council hereby approves and augments the funds for the hereunder Source of Funds and Destination of Funds for the herein mentioned offices.
