RESOLUTION AUTHORIZING HON. JO ABEGAIL C. DIONEDA, ACTING CITY VICE MAYOR, SORSOGON CITY TO BE THE SIGNATORY OF CHECKS AND OTHER DOCUMENTS RELATIVE TO THE TRANSACTIONS OF THE LEGISLATIVE DEPARTMENT OF THE CITY GOVERNMENT OF SORSOGON WITH THE LAND BANK OF THE PHILIPPINES (LBP) AND DEVELOPMENT BANK OF THE PHILIPPINES FOR THE PERIOD JUNE 2 TO 15, 2022.

WHEREAS, on June 2, 2022, Hon. Mark Eric C. Dioneda, Acting City Mayor, Sorsogon City wrote the Hon. Jo Abegail C. Dioneda, City Councilor, Sorsogon City informing her of his temporary designation to exercise the authority of the Local Chief Executive (LCE) during the latter's official travel on June 2-15, 2022;

WHEREAS, under the Local Government Code of 1991, the highest ranking Sangguniang Panlungsod Member, as Acting Vice Mayor, can perform all the duties and powers pertaining to the Office of the City Vice Mayor as head of the Legislative Department;
