RESOLUTION AUTHORIZING THE CHANGE OF LOCATION OF THE CONSTRUCTION OF A FARM TO MARKET ROAD FROM PUROK QUIRINO, BARANGAY BUHATAN, EAST DISTRICT, SORSOGON CITY TO BARAYONG-PAMURAYAN AREA, WEST DISTRICT, SORSOGON CITY.

WHEREAS, on June 07, 2022, Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote the Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting for the passage of a resolution authorizing the Change of Location of the Construction of a Farm to Market Road from Purok Quirino, Barangay Buhatan, East District, Sorsogon City to Barayong-Pamurayan Area;

WHEREAS, as indicated in the letter, the purpose of such change of location is to correct the inadvertent overlapping and redundancy of projects of the City Government and the Department of Public Works and Highways (DPWH);

WHEREAS, in addition thereto, such Change of Location would ensure that no government funds will go to waste and attend to the needs of the people in the process;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 7th City Council deemed it necessary to pass a resolution authorizing the Change of Location of the Construction of a Farm to Market Road from Purok Quirino, Barangay Buhatan, East District, Sorsogon City to Barayong-Pamurayan Area:
