**RESOLUTION REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO INCLUDE IN THE CITY GOVERNMENT'S PRIORITY AGENDA THE ESTABLISHMENT AND CONSTRUCTION OF A FIFTY-BED CAPACITY HOSPITAL IN BACON DISTRICT, SORSOGON CITY**

**WHEREAS**, Bacon District is used to be a municipality prior to its merging with the former Municipality of Sorsogon, to form the now City of Sorsogon;

**WHEREAS**, one of the attributes of being a municipality is the existence of facilities for delivery of basic services, such as a public market, slaughter house, hospital, public cemeteries, public transport terminal, ports, water reservoirs, public schools for all levels, and to some extent places for preservation and promotion of cultural heritage such as public parks, theaters, cockpits, and similar places for amusements;

**WHEREAS**, health, sanitation, and protection of the well-being of our constituents is a primary obligation not just by the State, but also by local government units as well;

**WHEREAS**, Bacon District, which is comprised of 28 barangays, has a population of almost fifty-thousand residents who will benefit once a hospital is established or constructed therein;

**NOW THEREFORE**, on motion of **Hon. Glenn P. Olbes** duly seconded by **Hon. Danilo A. Deladia**, resolve as it is hereby resolved to request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to include in the City Government's Priority Agenda, the construction and establishment of a fifty-bed capacity hospital for Bacon District, Sorsogon City to primarily serve the residents of the 28 barangays of the said district.
