RESOLUTION ADOPTING AND APPROVING THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC) RESOLUTION NO. 03, SERIES OF 2022 ENTITLED “RESOLUTION APPROVING THE REPROGRAMMING/ REALIGNMENT OF THE ACTIVITY AND BUDGET UNDER THE SPECIAL TRUST FUND BALANCE FOR CY 2020 AMOUNTING TO ONE HUNDRED THOUSAND (P100,000.00)

WHEREAS, on October 4, 2022, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, adoption and approval of City Disaster Risk Reduction And Management Council (CDRRMC) Resolution No. 03, Series of 2022 entitled “Resolution Approving The Reprogramming/ Realignment Of The Activity And Budget Under The Special Trust Fund Balance For Cy 2020 Amounting To One Hundred Thousand (P100,000.00)Pesos;

WHEREAS, under Section 5 of Rule 5 of the IRR of Republic Act No. 10121, Local DRRm Councils are mandated to conduct meetings once every three months with the Local DRR Officee serving as the Secretariat;

WHEREAS, in the Local DRRM Plan for CY 2022, the quarterly conduct of meeting was not listed, hence no budget was allocated;

WHEREAS, among the documents attached to the aforementioned letter of the Hon. MA. Ester E. Hamor was the CDRRMC Resolution No. 03-2022 for perusal of the 8th City Council;
