RESOLUTION ADOPTING AND APPROVING THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC) RESOLUTION NO. 04, SERIES OF 2022 ENTITLED “RESOLUTION APPROVING THE REPROGRAMMING/ REALIGNMENT OF THE PROJECT AND BUDGET UNDER THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PLAN (LDRRMP) FOR CY 2022 AMOUNTING TO TWO MILLION TWO HUNDRED THOUSAND (P2,200,000.00) PESOS

WHEREAS, on October 4, 2022, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, adoption and approval of City Disaster Risk Reduction And Management Council (CDRRMC) Resolution No. 04, Series of 2022 entitled “Resolution Approving The Reprogramming/ Realignment Of the Project and Budget Under the Local Disaster Risk Reduction and

Management Plan (LDRRMP) For Cy 2022 amounting to Two Million Two Hundred Thousand (P2,200,000.00) Pesos;

WHEREAS, one of the projects under the Disaster Prevention and Mitigation thematic area of the Local DRRM Plan is the construction and rehabilitation of flood control structure, specifically the construction of line canal at Barangay Cabid-an, East District, Sorsogon City with a corresponding allocation of Two Million Two Hundred Thousand (P2,200,000.00) Pesos;

WHEREAS, as per Engr. Roel D. Domer of the City Engineering Office, said project was earlier implemented thru another fund identified by the City Budget Office;

WHEREAS, among the documents attached to the aforementioned letter of the Hon. MA. Ester E. Hamor was the CDRRMC Resolution No. 04-2022 for perusal of the 8th City Council;

WHEREAS, foregoing premise considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution adopting and approving City Disaster Risk Reduction And Management Council (CDRRMC) Resolution No. 04, Series of 2022 entitled "Resolution Approving The Reprogramming/ Realignment of the Project and Budget Under the Local Disaster Risk Reduction and Management Plan (LDRRMP) For Cy 2022 amounting to Two Million Two Hundred Thousand (P2,200,000.00) Pesos;
