RESOLUTION FAVORABLY ADOPTING AND APPROVING THE CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 06, SERIES OF 2022 ENTITLED, “ RESOLUTION FAVORABLY APPROVING THE REPROGRAMMING OF THE PROPOSED UTILIZATION OF THE 20% DEVELOPMENT FUND OF THE CITY OF SORSOGON FOR FISCAL YEAR 2023

WHEREAS, on September 30, 2022 the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, adoption and approval of City Development Council (CDC) Resolution No. 06, Series of 2022 entitled, “Resolution Favorably Approving the Reprogramming of the Proposed Utilization of the 20% Development Fund of the City of Sorsogon for Fiscal Year 2023;
