RESOLUTION ISSUING TRICYCLE FRANCHISE TO FIVE (5) QUALIFIED WAITING APPLICANT FROM PREVIOUSLY CANCELLED/REVOKED TRICYCLE FRANCHISES UNDER SP RESOLUTION NO. 056, SERIES OF 2022 IN ACCORDANCE WITH CITY ORDINANCE NO. 22, SERIES OF 2020 OTHERWISE KNOWN AS THE "SORSOGON CITY NEW TRICYCLE FRANCHISE CODE OF 2020"

WHEREAS, SP Resolution No.056, Series of 2022, approved on February 15, 2022, 2022 officially cancelled and revoked tricycle franchises in favor of the city government of Sorsogon, in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the "Sorsogon City New Tricycle Franchise Code of 2020";

WHEREAS, on September 23 and 29, 2022, respectively, the Tricycle Franchising Regulatory Office through the SP Committee on Tricycle Franchise endorsed the five (5) qualified waiting applicants for the aforesaid cancelled/revoked tricycle franchises, to wit:

1. **Tricycle Franchise No. 2686/Tricycle Franchise Plate No. 2686** awarded in the name of **RENATO J. CARRANZA** of **Almendras Cogon, East District Sorsogon City**, with the route covered by **SCIKWA**
2. **Tricycle Franchise No. 2697/Tricycle Franchise Plate No. 2697** awarded in the name of **SALVADOR II LACASTE** of **Pamurayan, West District Sorsogon City**, with the route covered by **PAMPTODA**
3. **Tricycle Franchise No. 3067/Tricycle Franchise Plate No. 3067** awarded in the name of **PASCAUAL D. DORONELA** of **San Ramon, Bacon District Sorsogon City**, with the route covered by **SSBSCTODA**
4. **Tricycle Franchise No. 3108/Tricycle Franchise Plate No. 3108** awarded in the name **JOHN FRANCISCO D. SAÑEZ** of **Balete, Bacon District Sorsogon City**, with the route covered by **SSBSCTODA**
5. **Tricycle Franchise No. 3181/Tricycle Franchise Plate No. 3181** awarded in the name **AUGUSTO L. PAREJA** of **San Juan, Bacon District Sorsogon City**, with the route covered by **OTPTODA**

WHEREAS, Section 14 of City Ordinance No. 22-2020 (“Sorsogon City New Tricycle Franchise Code of 2020”) provides that The Sangguniang Panlungsod shall issue/grant franchise to operate a motorized tricycle for hire to qualified persons who desire to provide transport service to the general public by means of a motorized tricycle for monetary consideration. Being a privilege, it can be revoked, cancelled or withdrawn unilaterally at any time upon reasonable grounds;

NOW THEREFORE, on incidental motion of **Hon. Nestor J. Baldon** duly seconded by **Hon. Jo Abegail C. Dioneda**, resolved as it is hereby resolve to issue tricycle franchise to five (5) qualified waiting applicants from previously cancelled/revoked tricycle franchises under SP Resolution No. 056, Series of 2022 in accordance with City Ordinance No. 22, Series of 2020 otherwise known as the “Sorsogon City New Tricycle Franchise Code of 2020”.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
