RESOLUTION GRANTING AUTHORITY TO HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENTER FOR AND ON BEHALF OF THE SORSOGON CITY GOVERNMENT, INTO A USUFRUCTUARY AGREEMENT WITH THE RECIPIENTS OF THE CORE SHELTER HOUSING UNITS UNDER THE CITY GOVERNMENT'S BANNER "TAAS NOO, CUIDANO AKO MASS HOUSING PROGRAM"

WHEREAS, the City Government of Sorsogon is implementing a Mass Housing Project by constructing Core Shelters housing units under its development banner "TAAS NOO, CUIDANO AKO MASS HOUSING PROGRAM"
