RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE BUREAU OF FIRE PROTECTION (BFP) REPRESENTED BY SINSP ERIC A. CARAMOAN, ACTING CITY FIRE MARSHAL RELATIVE TO THE FIRE SAFETY INSPECTION COMPONENT OF THE BUSINESS PERMIT APPLICATION OF BUSINESS OWNERS IN THE CITY OF SORSOGON.

WHEREAS, among the items deliberated during the October 18, 2022 Regular Session of the 8th City Council is Transmittal No. 68, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated October 10, 2022 requesting for the passage of a Resolution authorizing her to enter into a Memorandum of Agreement (MOA) with the Bureau of Fire Protection (BFP) represented by Sinsp Eric A. Caramoan, Acting City Fire Marshal relative to the Fire Safety Inspection component of the Business Permit Application of business owners in the City of Sorsogon;

WHEREAS, Section 5 of Republic Act 9514 also known as the Fire Code of the Philippines of 2008 and its Revised Implementing Rules and Regulations (RIRR) authorizes the Chief of the BFP to enter into a Memorandum of Agreement with other departments, bureaus, agencies, offices and corporations of the government, as well as private institutions, in order to define areas of cooperation and coordination and delineate responsibility on fire prevention education, fire safety, fire prevention, fire suppression and other matters of common concern;

WHEREAS, Section 12 (h) of Republic Act No. 11032 has vested the BFP the discretion to enter into agreements with cities or municipalities to allow the latter to assess and collect fire safety inspection fees;

WHEREAS, in said Memorandum of Agreement (MOA), the partnership between the LGU and BFP is defined in accordance with the Fire Code of the Philippines and the Ease of Doing Business Act as this will establish a system of collection and remittance of applicable fees that can be used for more expeditious processing of documents hence this development will be of great help in the streamlining of the frontline services and augment the optimum implementation of the year round Business One Stop Shop (BOSS);

WHEREAS, attached to the transmittal is a copy of a draft Memorandum of Agreement for further perusal of the 8th City Council;

NOW THEREFORE, on incidental motion of **Hon. Glenn P. Olbes**, duly seconded by **Hon. Nestor J. Baldon**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Bureau of Fire Protection (BFP) represented by SInsp Eric A. Caramoan, Acting City Fire Marshal relative to the Fire Safety Inspection component of the Business Permit Application of business owners in the City of Sorsogon;

RESOLVED FURTHER, that the Memorandum of Agreement entered into by parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;


RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information and guidance.
