RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), REPRESENTED BY ITS REGIONAL DIRECTOR, ATTY. ARNALDO ESCOBER, RELATIVE TO THE INNOVATIONS AND MANAGEMENT BANKING AND KNOWLEDGE SHARING (IMBAK) SYSTEM.

WHEREAS, among the items deliberated during the October 18, 2022 Regular Session of the 8th City Council is Transmittal No. 69, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated October 11, 2022 requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with the Department of the Interior and Local Government (DILG), represented by its Regional Director, Atty. Arnaldo Escobar, relative to the Innovations and Management Banking and Knowledge Sharing (IMBAK) System;

WHEREAS, the DILG Region V – Bicol Local Governance Regional Resource Center (DILG REGIO V LGRRC) aims to promote a culture of learning and knowledge sharing in pursuit of sustainable development through excellence in local governance;

WHEREAS, the DILG Region V LGRRC Knowledge Hub is a physical library that features a collection of printed learning resources and other knowledge products that is open for researchers, local officials and functionaries and all other users in need of materials on local governance;

WHEREAS, to maximize the operation of the Knowledge Hub and enhance the provision of capacity development to local governments, the DILG REGION V LGRRC developed the Innovations and Management Banking and Knowledge Sharing (IMBAK) System;

WHEREAS, the IMBAK System is a tool that will manage knowledge sharing by allowing the depositors or partner stakeholders to deposit their knowledge products and share innovations on program implementation relative to local governance;

WHEREAS, attached to the transmittal is a copy of a draft Memorandum of Agreement for further perusal of the 8th City Council;

NOW THEREFORE, on incidental motion of **Hon. Jo Abegail C. Dioneda** duly seconded by Hon. Renalene Mae J. Duka, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with the Department of the Interior and Local Government (DILG), represented by its Regional Director, Atty. Arnaldo Escobar, relative to the Innovations and Management Banking and Knowledge Sharing (IMBAK) System;

RESOLVED FURTHER, that the Memorandum of Agreement entered into by parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;
