RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY THE CITY GOVERNMENT OF SORSOGON, REPRESENTED BY ITS CITY MAYOR, HON. MA. ESTER E. HAMOR RELATIVE TO THE SUPPLEMENTAL DIETARY PROGRAM AMOUNTING TO SIX MILLION FOUR HUNDRED FIFTY-ONE TWENTY AND 50/100 PESOS (PHP 6,451,020.50).

WHEREAS, among the items deliberated during the October 18, 2022 Regular Session of the 8th City Council is Transmittal No. 70, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated October 11, 2022 requesting for the passage of a Resolution ratifying the Contract entered into by the City Government of Sorsogon, represented by its City Mayor, Hon. Ma. Ester E. Hamor relative to the Supplemental Dietary Program amounting to Six Million Four Hundred Fifty-One Twenty and 50/100 Pesos (Php 6,451,020.50);

WHEREAS, the City Government of Sorsogon in connection with the programs on social welfare and development facilitated the procurement process on the Supply and Delivery of Various Food Stuff for Supplemental Dietary Program amounting to Six Million Four Hundred Fifty-One Thousand Twenty and 50/100 Pesos (Php 6,451,020.50);

WHEREAS, for its expeditious completion, the LGU entered into contract with the winning bidder who shall ensure the complete delivery of items required for the effective and efficient implementation of the Supplemental Dietary Program;

WHEREAS, attached to the transmittal is a copy of a draft Contract of Agreement for further perusal of the 8th City Council;
