## *Resolution No. 313, Series of 2022*

**RESOLUTION MOST RESPECTFULLY REQUESTING THE HON. MARIE BERNADETTE G. ESCUDERO, 1<sup>ST</sup> DISTRICT REPRESENTATIVE, PROVINCE OF SORSOGON, TO ALLOCATE FUNDS INTENDED FOR THE ROADS OPENING AND CONSTRUCTION OF DEVELOPMENTAL ROUTES IN THE CITY OF SORSOGON AS HEREIN IDENTIFIED FOR THE PURPOSE**

**WHEREAS**, during the formulation of plans and programs for the Executive-Legislative Agenda (ELA) and Capacity Development Agenda held on September 20-23 at Taal Vista Hotel, Tagaytay City, the Infrastructure, Land Use and Physical Development Sector presented its proposal for the openings of developmental roads in the city of Sorsogon;

**WHEREAS**, the Infrastructure, Land Use and Physical Development Sector has identified the following roads opening and further construction of developmental roads, to wit:

1. From OLV Bibincahan (East) connecting Brgy. Balogo (East) through Encarnacion Street, near SM-Sorsogon.
2. From Brgy. Bibincahan (East)-near Brgy. Hall connecting to the Diversion Road Brgy. Cabid-an (East), near the proposed New City Hall (or BMEG Bldg.).
3. From Cattleya Homes Subd. Brgy. Bibincahan (East) connecting to portion of the Diversion Road, Brgy. Cabid-an (East).
4. From SPPVS Gate 2, Brgy. Bibincahan (East) connecting Brgy. San Juan (East) near Ambrocio J. Labrador Elementary School.
5. From Brgy. San Juan (East), at former Amberg Hospital connecting to Maharlika Highway, boundary of Brgy. Pangpang and Brgy. Tugos (West).
6. From Diversion Road, Brgy Macabog (West), in front of Wilcon connecting Brgy. Piot (West).
7. Widening of Barangay Road from Magsaysay Street Extension, Barangay Bibincahan up to Barangay Balogo with provision on covered line canal and solar streetlights for pedestrians.
8. Widening and connection the Mahingan Road up to Coastal Road with provisions on covered line canal and solar streetlights for traffic rerouting and as an alternate road.

**WHEREAS**, the identified locations for roads opening to be developed into developed into alternate roads could provide convenient less travelled alternative and accessible motorways;

**WHEREAS**, at present statistics reveal that numerous accidents involving tricycles-for-hire occurred due to improper and indiscriminate usage of the national highway resulting in injuries, loss of lives and damage to properties;

**WHEREAS**, by the opening of new alternate roads as new established and recognized routes, tricycles-for-hire could be accommodated thereat and thereby precluding them to operate along the national highways in compliance with the laws, rules and regulations executed for the purpose;

**WHEREAS**, in effect, a loop service operated by modernized PUVs or PUJs could be established in the commercial district of the City of Sorsogon, for the convenience of the general public;

**WHEREAS**, opening of the said new developmental/alternate roads could minimized urban traffic, if not totally resolved;

**WHEREAS**, the City Government shall pursue a more proactive and preventive approach to secure the safety of motorist, passenger, pedestrians and preserve and protect lives and properties at all times;

**NOW THEREFORE**, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Peter Joseph J. Ravanilla**, resolved as it is hereby resolve to respectfully request the Hon. Marie Bernadette G. Escudero, 1<sup>st</sup> District Representative, Province of Sorsogon to

allocate funds intended for the roads opening and construction of developmental roads in the City of Sorsogon as herein identified for the purpose.

**RESOLVED FINALLY**, that copies of this resolution be furnished to all concerned for their information and guidance.
