RESOLUTION ADOPTING THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (CDRRMC) RESOLUTION NO. 07-2022 ENTITLED, "RESOLUTION APPROVING THE REALIGNMENT OF THE PROGRAM AND BUDGET UNDER THE SPECIAL TRUST FUND (5%LOCAL DRRM FUND OF CY 2020) AMOUNTING TO TWO MILLION (P2,000,000.00) PESOS

WHEREAS, among the items deliberated during the October 18, 2022 Regular Session of the 8th City Council was the letter from the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City dated October 4, 2022 addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and the Honorable Members of the Sangguniang Panlungsod requesting for a passage of a resolution adopting the attached resolution of the CDRRMC;

WHEREAS, by virtue of Presidential Proclamation No. 57 which further extends the period of state of calamity throughout the country due to corona virus disease, the Local Government Unit can readily use the 30% Quick Response Fund under the Local DRRM Fund;

WHEREAS, the City Planning and Development Office (CPDO) appealed to the body for fund augmentation for the on-going Community Based Monitoring System (CBMS) implemented by said office;

WHEREAS, in response to the appeal, the City Budget Office proposed the object of expenditure under the Special Trust Fund Balance (5% LDRRMF CY 2020) to wit:
