RESOLUTION INTERPOSING NO OBJECTION ON THE PROJECT FOR PROCESSING OF MAYOR'S PERMIT BY MS. GAZEL M. ESPINAS, OWNER, BATUHAN GAS STATION LOCATED AT BATUHAN, BARANGAY SAN ROQUE, BACON DICTRICT, SORSOGON CITY.

WHEREAS, on August 22, 2022 Ms. Roxamina A. Dioneda, Owner, YUNO Gas Station wrote a letter addressed to the Hon. Mark Eric C.
