RESOLUTION FAVORABLY ENDORSING TO THE SANGGUNIANG PANLALAWIGAN THROUGH HON. KRUNIMAR ESCUDERO, III, VICE GOVERNOR, PROVINCE OF SORSOGON, THE ISSUES AND CONCERNS RAISED BY HOG RAISERS AND BACKYARD HOG RAISERS IN THE CITY OF SORSOGON.

WHEREAS, on October 04, 2022, Engr. Mary Joy Mengorio wrote a letter addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor through Hon. Danilo A. Deladia, Chairman Committee on Agriculture and Food; and Hon. Peter Joseph J. Ravanilla, Chairman, Committee on trade, Commerce and Industry formally requesting for a meeting to discuss issues and concerns relative to the complaints of Hog Raiser in relation to the rapid decrease on the Live Weight of Livestock;

WHEREAS, on October 24, 2022, the Committee on Agriculture and Food and the Committee on Trade, Commerce and Industry conducted a Joint Committee Hearing inviting the presence of Hog Raisers and Backyard Hog Raisers in the City of Sorsogon;
