**RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH SORSOGON STATE UNIVERSITY (SSU) REPRESENTED BY ITS SUC PRESIDENT III, DR. GERALDINE F. DE JESUS, ED. D., RELATIVE TO THE DEVELOPMENT OF A LINKAGE FOR THE DEVELOPMENT AND IMPLEMENTATION OF PROGRAMS ON DISASTER RESILIENCE.**

**WHEREAS**, among the items deliberated during the October 25, 2022 Regular Session of the 8<sup>th</sup> City Council is Transmittal No. 74, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated October 20, 2022 requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with Sorsogon State University (SSU) represented by its SUC President III, Dr. Geraldine F. De Jesus, Ed. D., relative to the development of a linkage for the development and implementation of programs on disaster resilience;

**WHEREAS**, the DILG Region V – Bicol Local Governance Regional Resource Center (DILG REGIO V LGRR) aims to promote a culture of learning and knowledge sharing in pursuit of sustainable development through excellence in local governance;

**WHEREAS**, it is the policy of the State to uphold the right of the people to life, liberty and property by addressing the root causes of vulnerabilities to disasters, and strengthening the country's institutional capacity for disaster risk reduction and management, and building the resilience of local communities to disasters including climate change impacts in accordance with RA 10121 or the Philippine Disaster Risk Reduction and Management Act of 2010;

**WHEREAS**, the University aims to develop consortia and other economic forms of linkages with local government units (LGUs), in furtherance of the purpose and objectives of the university as contained in RA 11088;

**WHEREAS**, one of the core values being promoted by the University is resiliency towards this, the partnership with the LGUs will enable the educational institution to maximize its capacity to adapt in an environmentally-challenged setting, on one hand, and mitigate prejudicial effects of disaster to the community, on the other;

**WHEREAS**, in line with its commitment to provide sustainable development and ensure security and safety of the people, the CLGU, through its Disaster Risk Reduction and Management Office, have committed in carrying out emergency measures and responses before, during, and in the aftermath of man-made and natural disasters and this shared partnership aims to promote involvement and participation of all sectors especially the academes and higher educational institutions in adopting a comprehensive, efficient and competitive disaster risk-approach;

**WHEREAS**, attached to the transmittal is a copy of a draft Memorandum of Agreement for further perusal of the 8<sup>th</sup> City Council;

**NOW THEREFORE**, on incidental motion of **City Councilor Nestor J. Baldon**, duly seconded by **City Councilor Jo Abegail C. Dioneda**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with Sorsogon State University (SSU) represented by its SUC President III, Dr. Geraldine F. De Jesus, Ed. D., relative to the development of a linkage for the development and implementation of programs on disaster resilience;

**RESOLVED FURTHER**, that the Memorandum of Agreement entered into by parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;
