RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF ENCONTRADA SPONSORED BY THE ALPHA KAPPA RHO- OMIAS CHAPTER OF TALISAY, SORSOGON CITY REPRESENTED BY IVAN J. BALAORO SCHEDULED ON NOVEMBER 22, 23 & 24, 2022 AT SORSOGON CITY CENTRAL COCKPIT COLISEUM, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the October 25, 2022 Regular Session of the 8th City Council was the letter from Mr. Ivan J. Balaoro of AKRHO-OMIAS Chapter of Brgy. Talisay, WD, Sorsogon City requesting for a passage of a resolution authorizing and approving the conduct of encontrada scheduled on November 22, 23 & 24, 2022 at Sorsogon City Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

WHEREAS, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement through the owner of the cockpit and shall be given to the respective charitable institution and that the party shall faithfully comply therewith;

WHEREAS, the Inter Agency Task Force on Covid19 (IATF) Resolution No. 154, Series of 2021 and to the existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the City;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution approving and authorizing the conduct of *encontrada* sponsored by Mr. Ivan J. Balaoro of AKRHO-OMIAS Chapter of Brgy. Talisay, WD, Sorsogon City scheduled on November 22, 23 & 24, 2022 at Sorsogon City Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;
