WHEREAS, the BACON SANDATAAN ASSOCIATION (METRO MANILA) INC. OR BASAI, composed of its members coming from Metro Manila, in coordination with the MAisog Na Sandataan kan Bacon (Local chapter of BASAI), has been unconditionally serving the Bacongnons for almost 87 years since the inception of the original Bacon Sandataan Association in 1935;

WHEREAS, on October 22 and 23, 2022, the following BASAI officers and members namely Mr. Arnold Trapani (President) and wife, Atty. Salvador “Dong” Lorbes (BOD) and wife, Atty. Dondon Tenorio (BOD) and wife, Mr. Amaro Dellosa (Vice President) and wife, Retired General Escote and wife, MR. Espinola and others who joined the above-named officers, conducted medical missions in Brgy. Buenavista and Brgy. San Juan, both in Bacon District, Sorsogon City, respectively;

WHEREAS, all the way from Metro Manila, they brought several boxes of medicines and vitamins (for all ages), with three (3) doctors who are mostly spouses of BASAI officers, had conducted said medical missions to serve the Bacongnons who are in dire need for medical attention, as well as for necessary medicines of their common diseases;
