RESOLUTION AUTHORIZING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH SORSOGON PUERICULTURE CENTER, INC. REPRESENTED BY MRS. PLACER J. BALMACEDA, PRESIDENT AND CHIEF OPERATIONS OFFICER RELATIVE TO THE FINANCIAL ASSISTANCE EXTENDED BY THE CITY GOVERNMENT AMOUNTING TO ONE HUNDRED THOUSAND (P100,000.00) PESOS PER ANNUM.

WHEREAS, among the items deliberated during the November 08, 2022 Regular Session of the 8th City Council is Transmittal No. 78, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary dated November 02, 2022 requesting for the passage of a Resolution authorizing the Local Chief Executive to enter into a Memorandum of Agreement (MOA) with Sorsogon Puericulture Center, Inc. represented by Mrs. Placer J. Balmaceda, President and Chief Operations Officer relative to the financial assistance extended by the City Government amounting to One Hundred Thousand (P100,000.00) Pesos per annum;

WHEREAS, Sorsogon Puericulture Center, Inc. requested financial assistance from the City Government of Sorsogon with its programs and services, giving free medical check-up and medicines for the indigent families especially children and women in Sorsogon City and nearby municipalities;

WHEREAS, the City Government hereby grants Sorsogon Puericulture Center, Inc. a yearly financial assistance in the amount of One Hundred Thousand Pesos (P100,000.00) which will be released in four tranches;

WHEREAS, Sorsogon Puericulture Center, Inc. shall furnish the City Government of Sorsogon an official receipt, acknowledging the assistance and shall adopt a generally acceptable accounting and auditing procedures relative to the handling of the grant thus shall allow Visitorial Audit by the Official and Personnel of the COA authorized to perform the audit under an approved Office Order;

WHEREAS, the City Government of Sorsogon will conduct monitoring and inspection of program implementation and verification financial records and reports of Sorsogon Puericulture Center, Inc.;

WHEREAS, Sorsogon Puericulture Center, Inc. will submit the required periodic financial and physical status reports (no subsequent fund transfer must be granted unless previous fund transfer has been liquidated and required physical status report has been submitted) thus will liquidate the fund immediately upon completion of the project and before the release of the next tranche;

WHEREAS, attached to the transmittal is a copy of a draft Memorandum of Agreement for further perusal of the 8th City Council;

NOW THEREFORE, on motion of **City Councilor Nestor J. Baldon**, duly seconded by **City Councilor Jo Abegail C. Dioneda**, resolve as it is hereby resolved to authorize the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enter into a Memorandum of Agreement (MOA) with Sorsogon Puericulture Center, Inc. represented by Mrs. Placer J. Balmaceda, President and Chief Operations Officer relative to the financial assistance extended by the City Government amounting to One Hundred Thousand (P100,000.00) Pesos per annum;

RESOLVED FURTHER, that the Memorandum of Agreement entered into by parties herein mentioned shall be an integral part of this resolution and copies of the same be furnished to the Sangguniang Panlungsod for record and archive purposes;

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned for their information and guidance.
