RESOLUTION ADOPTING THE REVITALIZED PNP KASIMBAYANAN (Kapulisan, Simbahan at Pamayanan) AND TO FAST TRACK THE IMPLEMENTATION OF THE SAME AS AN EFFECTIVE MECHANISM FOR CRIME PREVENTION AND CONTROL STRATEGY OF THE PHILIPPINE NATIONAL POLICE – SORSOGON CITY

WHEREAS, Executive Order No. 16, S. 2017, dated 04 April 2017, issued by the Office of the President, Malacañang, adopted the National Security Policy 2017-2022, which calls for the end of all armed threats in the Philippines and recognizes that internal socio-political stability rest upon healing the rifts that divide the nation by promoting participatory governance, synergy of government development efforts, and enhancing the participation and responsibilities of local government units (LGUs);

WHEREAS, Section 1, of EO 16 series of 2017, by the adoption thereof by the National Security Policy (NSP) 2017-2022, directed all government departments and agencies, including Government Owned and Controlled Corporations (GOCCs) and LGUs to adopt the NSP 2017-2022

in the formulation and implementation of all their plans and programs which have national security implications;

WHEREAS, Section 5, of EO No. 70 provided and established the National Peace Framework which contains the principles, policies, plans and programs that will bring inclusive and sustainable peace, and address the root causes of insurgencies, internal disturbances and tensions as well as other armed conflicts and threats in identified areas. The framework shall be responsive to local needs and sensitive to realities on the ground. To this end, the framework shall include a mechanism for localized peace engagements or negotiations and interventions that is nationally orchestrated, directed and supervised, while being locally implemented;

WHEREAS, the representation recognizes the need to adopt and implement immediately in the jurisdictional political area to Revitalized PNP KASIMBAYANAN, thus, the latter empowers the contribution of "Church and Community" wherein volunteer church leaders from different religious organizations shall help the police nurture relations with the community and in bridging the gap between the two leading peace advocates which geared toward the prevention of crimes, sustainability of peace and order and a climate of trust and respect among the citizenry;

WHEREAS, the proponent of this resolution strongly requests and urges the City Peace and Order Council to support and Adopt the Revitalized PNP KASIMBAYANAN and therefore take this as an URGENT matter;

NOW THEREFORE, on motion of **City Councilor Bryan J. Pingul**, duly seconded by **City Councilor Jo Abegail C. Dioneda**, and by unanimous assent of the 8th City Council, be it resolve as it is hereby resolved to adopt the Revitalized PNP KASIMBAYANAN and to fast track the implementation of the same as an effective mechanism for crime prevention and control strategy of the Philippine National Police – Sorsogon City.
