**RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 5, SERIES OF 2022 FROM THE BARANGAY COUNCIL OF BARANGAY BULABOG, WEST DISTRICT, SORSOGON CITY ENTITLED “AN ORDINANCE AUTHORIZING THE CITY OF SORSOGON TO ISSUE BARANGAY CLEARANCE AND COLLECT CORRESPONDING BARANGAY CLEARANCE FEES IN THE APPLICATION FOR ANY BUSINESS RELATED TRANSACTIONS SUBJECT TO THE REMITTANCE OF THE AFORESAID FEES TO THE BARANGAY AND THE CONDITIONS HEREUNDER”**

**WHEREAS**, Barangay Ordinance No. 5, Series of 2022 from the Barangay Council of Barangay Bulabog, West District, Sorsogon City was among the items deliberated upon by the 8<sup>th</sup> City Council during the November 08, 2022 Regular Session;

**WHEREAS**, cursory reading of the submitted barangay ordinance reveals that the said barangay ordinance is within the ambits of the powers conferred to the barangay council by virtue of Chapter 4, Section 391 of Republic Act 7160 otherwise known as the Local Government Code of 1991.

**WHEREAS**, the Sangguniang Panlungsod finds the barangay ordinance intra vires as mandated by the Local Government Code of 1991;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution declaring valid Barangay Ordinance No. 5, Series of 2022 from the Barangay Council of Barangay Bulabog, West District, Sorsogon City entitled "An ordinance authorizing the City of Sorsogon to issue barangay clearance and collect corresponding barangay clearance fees in the application for any business related transaction subject to the remittance of the aforesaid fees to the barangay and the conditions hereunder";

**NOW THEREFORE**, on motion of **Hon. Angelu Magda P. Ravanilla** duly seconded by **Hon. Danilo A. 
