RESOLUTION AUTHORIZING HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO FACILITATE THE PURCHASE OF A PARCEL OF LAND CONSISTING AN AREA OF ONE THOUSAND (1,000 SQ.M) SQUARE METERS FOR ONE THOUSAND TWO HUNDRED PESOS (₱1,200.00) PER SQUARE METER LOCATED AT BARANGAY SAN JUAN, BACON DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the November 08, 2022 Regular Session of the 8th City Council was the letter from Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City addressed to Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City thru Mr. Rovon E. Domasian, SP Secretary, dated November 02, 2022 requesting for the passage of a resolution authorizing the City Mayor to facilitate the purchase of a parcel of land consisting an area of One Thousand square meters for One Thousand Two Hundred Pesos per square meter located at Barangay San Juan, Bacon District, Sorsogon City;

WHEREAS, the said parcel of land is a portion of an agricultural property situated at San Juan, Bacon District, Sorsogon City covered by Tax Declaration No. 2011-01-0018-00335 under the name of Mr. Mamerto Te;

WHEREAS, after the transfer of ownership of the said property, the parcel of land shall be used for the construction of a Multipurpose Building which can be used to hold programs on youth and sports development as well as an evacuation center in times of calamities and a venue for other activities;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution authorizing the City Mayor to facilitate the purchase of a parcel of land consisting an area of One Thousand square meters for One Thousand Two Hundred Pesos per square meter located at Barangay San Juan, Bacon District, Sorsogon City;

NOW THEREFORE, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Danilo A. Deladia**, resolved as it is hereby resolve to authorize the City Mayor to facilitate the purchase of a parcel of land consisting an area of One Thousand square meters for One Thousand Two Hundred Pesos per square meter located at Barangay San Juan, Bacon District, Sorsogon City;
