**RESOLUTION ADOPTING, APPROVING AND ENACTMENT OF AN ORDINANCE OF THE CITY DEVELOPMENT COUNCIL -EXECUTIVE COMMITTEE RESOLUTION NO. 02, SERIES OF 2022 ENTITLED “REALIGNMENT OF TWELVE MILLION SIX HUNDRED THIRTY THREE THOUSAND TWO HUNDRED SEVENTY FOUR AND 70/100 (P12,633, 274. 70) PESOS FROM 2021 20% DEVELOPMENT FUND ITEM III-4 (CONSTRUCTION OF MARKET STALLS @BACON DISTRICT) AND 2022 20% DEVELOPMENT FUND ITEM III-2 AND ITEM NO. **WHEREAS**, on November 3, 2022, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the Honorable Members of the Sangguniang Panlungsod thru Hon. Mark Eric C. Dioneda, City Vice Mayor, Sorsogon City respectfully requesting among others, enactment of appropriation ordinance, adoption, approval of City Development Council (CDC) Executive Committee Resolution No. 02, Series of 2022 entitled "REALIGNMENT OF TWELVE MILLION SIX HUNDRED THIRTY THREE THOUSAND TWO HUNDRED SEVENTY FOUR AND 70/100 (P12,633, 274. 70) PESOS FROM 2021 20% DEVELOPMENT FUND ITEM III-4 (CONSTRUCTION OF MARKET STALLS @BACON DISTRICT) AND 2022 20% DEVELOPMENT FUND ITEM III-2 AND ITEM NO. V-3 (IMPROVEMENT OF SORSOGON CITY PUBLIC MARKET AND CONSTRUCTION OF LOCAL ROAD) TO ITEM NO. **WHEREAS**, the Local Government Unit of Sorsogon City in compliance with Republic Act 7160 otherwise known as the Local Government Code of 1991 particularly Section 106 sets to implement projects, programs and activities in the direction of economic and social development in the Local Government;

**WHEREAS**, the bridge at Barangay Gimaloto undergone rehabilitation wayback 2007 and no rehabilitation or improvement has been done;

**WHEREAS**, the construction and rehabilitation of multipurpose building at Barangay Bogña , Buenavista, Bibincahan and Pangpang respectively will serve as evacuation centers;
