RESOLUTION EXPRESSING THE INTENTION OF THE CITY GOVERNMENT OF SORSOGON TO DONATE FOUR (4) PARCELS OF LAND AS HEREIN IDENTIFIED IN FAVOR OF THE CONCERNED EDUCATIONAL INSTITUTIONS WHERE THE SAID PROPERTIES ARE SITUATED

WHEREAS, the Sangguniang Panlungsod was in receipt of Transmittal No. 62, Series of 2022 from the Office of the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City, addressed to the Hon. Mark Eric C. Dioneda, City Vice Mayor and Honorable Members of the Sangguniang Panlungsod thru the SP Secretary, dated September 27, 2022 RE: Requests for the passage of a Resolutions authorizing the Local Chief Executive to donate and transfer the ownership of parcels of land from the City Government to the following educational institutions:

1. Portion of Transfer Certificate of Title No. Y-4823, Lot No. 222-C, Psd-05-026734 situated at Panlayaan, West District, Sorsogon City.

2. Lot No. 41000 Lot No. 029 Blk 03 containing an area of 7485 square meters more or less situated at Pamurayan, West District, Sorsogon City.
3. A parcel of land consisting an area of 4006 square meters under Tax Declaration No. 21157 located at Penafrancia, West District, Sorsogon City.
4. A parcel of land situated at Cabarbuhan, Bacon District, Sorsogon City which is a part of Tax Declaration No. 18410;

WHEREAS, the same was calendared during the October 4, 2022 Regular Session of the 8th City Council and was subsequently referred to the joint Committees on City Properties and of the Committee on Land Use, Urban Planning and Housing;

WHEREAS, the Committees on City Properties and of the Committee on Land Use, Urban Planning and Housing, on its Joint Committee Report thereby recommended that prior to the passage of a resolution, the Legal Officer designate of the DepEd-Sorsogon City shall submit first to the City Assessor the pertinent documents relative to the subject properties and the DepEd-Sorsogon City shall draft the Deed of Conditional Donation stipulating clearly the use of lot for educational purposes and to be submitted for perusal of the City Mayor and of the City Legal Officer;

WHEREAS, pending the approval of the request of the Hon. City Mayor Ma. Ester E. Hamor for the passage of a Resolutions authorizing the Local Chief Executive to donate and transfer the ownership of the four (4) parcels of land from the City Government to the concerned educational institutions, the 8th City Council deemed it just, proper and necessary to express its intention to donate the same;

NOW THEREFORE, on motion of **Hon. Mark Jayson D. Jamisola**, duly seconded by **Hon. Glenn P. Olbes** resolved as it is hereby resolve to express the intention of the City Government of Sorsogon to donate four (4) parcels of land as herein identified in favor of the concerned educational institutions where the said properties are situated.

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned for their information and guidance.
