RESOLUTION APPROVING AND AUTHORIZING THE CONDUCT OF THREE (3) STAG ELIMINATION SPONSORED BY THE NATIONAL BREEDERS ALLIANCE (NBA) SCHEDULED ON NOVEMBER 18, 2022 AT THE SORSOGON CITY CENTRAL COCKPIT COLISEUM, BARANGAY BIBINCAHAN, EAST DISTRICT, SORSOGON CITY

WHEREAS, among the items deliberated during the November 15, 2022 Regular Session of the 8th City Council was the letter dated November 14, 2022 relative to the request for the conduct of 3 stag elimination sponsored by the National Breeders Alliance (NBA) scheduled on November 18, 2022 at the Sorsogon City Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;

WHEREAS, as per consensus, a certain amount of the total share of the requesting party from the derby shall be reserved and retained by the Committee on Games and Amusement through the owner of the cockpit and shall be given to the respective

charitable institution (Barangay Salog Senior Citizen) and that the party shall faithfully comply therewith;

WHEREAS, the Inter Agency Task Force on Covid19 (IATF) Resolution No. 154, Series of 2021 and to the existing laws and regulations and as provided by Republic Act 7160 otherwise known as the Local Government Code of 1991, the Sangguniang Panlungsod has the power to regulate the conduct of cockfighting within the territorial jurisdiction of the City;

WHEREAS, foregoing premises considered and after due deliberation on the matter, the 8th City Council deemed it necessary to pass a resolution approving and authorizing the conduct of 3 stag elimination sponsored by the National Breeders Alliance (NBA) scheduled on November 18, 2022 at the Sorsogon City Central Cockpit Coliseum, Barangay Bibincahan, East District, Sorsogon City;
