**WHEREAS**, in line with the mandate of the legislative department, voluminous documents are being presented before the 8<sup>th</sup> City Council and requiring the Office of the Secretary to Sangguniang Panlungsod to furnish printed copies of the same prior to the conduct of Regular and Special Sessions;
