RESOLUTION FAVORABLY INDORSING TO THE LOCAL CHIEF EXECUTIVE, MA. ESTER E. HAMOR, THE LETTER REQUEST OF THE HOUSEHOLD RESIDENTS OF SITIO GABAO, BRGY., SAN ROQUE, BACON DIST., SORSOGON CITY, TO PROVIDE THEM AN INGRESS AND EGRESS RIGHT OF WAY LEADING TO THE NEAREST HIGHWAY.

WHEREAS, this representation was in receipt of the letter request of the household residents of Sitio Gabao, Brgy., San Roque, Bacon Dist., Sorsogon City, dated July 12, 2022, requesting to provide them an ingress and egress right of way in their area;

WHEREAS, the communal and traditional ingress and egress right of way utilize by the household thereto was fenced already by the respective private land owners;

WHEREAS, in view of the construction of fences of the respective private land owners, the church goers can no longer go and attend the mass, the agricultural produced

can no longer be carried out going to market, the students felt extra hardship on their day to day dealing in finding passable ways going through and forth from their houses to school;

NOW THEREFORE, on motion of **Councilor Glenn P. Olbes**, duly seconded by **Hon. Nestor J. Baldon**, resolve as it is hereby resolved, to favorably indorse to the Local Chief Executive, Ma. Ester E. Hamor, the Request Letter of the Household Residents of Sitio Gabao, Brgy., San Roque, Bacon Dist., Sorsogon City, to Provide them an Ingress and Egress Right of Way leading to the Nearest Highway.
