**RESOLUTION COMMENDING THE BARANGAY POLICE OFFICERS/

IN A ROBBERY INCIDENT THERETO**

WHEREAS, Barangay Tanod Brigades were organized to assist the government in the maintenance of peace and order in the country;

WHEREAS, pursuant to such duties, the same conducts rondas or nightly patrol, necessarily exposing their lives and limbs to danger in the hands of criminal elements and other wayward members of the society;

WHEREAS, on November 6, 2022, a Barangay Blotter report was recorded involving the apprehension of Oliver Madriaga Jerrera, 22 years old and a resident of Brgy. Macabog, West District, Sorsogon City responsible for breaking and entering the

home of Mrs. Salvacion Enorme taking her belongings at Purok 4, Capuy, West District, Sorsogon City;

WHEREAS, this representation commends the team for their active participation in the hot pursuit which led to the arrest of the suspects thereby giving immediate peace to the status quo;

WHEREAS, the Sangguniang Panlungsod of Sorsogon City supports this undertaking and hereby commends all Barangay Tanods who took part in this hot pursuit;

NOW THEREFORE, on motion of **Hon. Peter Joseph J. Ravanilla**, duly seconded by **Hon. Renalene Mae J. Duka**, resolve as it is hereby resolved, to commend the Barangay Police Officers/ Barangay Tanod of Barangay Capuy, West District, Sorsogon City for the immediate apprehension of the suspect involved in a robbery incident thereto.
