**RESOLUTION RESPECTFULLY REQUESTING SK FEDERATION PRESIDENT HONORABLE RENALENE MAE J. DUKA AND THE SK CHAIRPERSON OF SIXTY FOUR (64) BARANGAYS OF SORSOGON CITY TO PRIORITIZE THE CONDUCT OF ADOLESCENT AND YOUTH REPRODUCTIVE HEALTH AWARENESS SEMINAR IN THEIR RESPECTIVE BARANGAYS.**

**WHEREAS**, Section 8 (d) of Republic Act 10742 or the Sangguniang Kabataan Reform Act of 2015 states that the Sangguniang Kabataan should initiate and implement programs and projects designed to promote general welfare, development and empowerment of the youth.

**WHEREAS**, Adolescence is a period of transition from childhood to adulthood during which adolescent develop biologically and psychologically.

**WHEREAS**, there is an increasing rate of early pregnancy among adolescents and there is a big chance to die prematurely and unnecessarily through pregnancy related-conditions,

**WHEREAS**, addressing the needs of adolescents is an intergenerational investment of huge benefits to the next generation that's why it is imperative that the youth sectors be given preferential attention by the government.

**NOW THEREFORE**, on motion of **Hon. Mark Jayson D. Jamisola**, duly seconded by **Hon. Nestor J.
