RESOLUTION RESPECTFULLY REQUESTING SK FEDERATION PRESIDENT HONORABLE RENALENE MAE J. DUKA AND THE SK CHAIRPERSON OF SIXTY FOUR (64) BARANGAYS OF SORSOGON CITY TO PRIORITIZE THE CONDUCT OF MENTAL HEALTH AWARENESS PROGRAM FOR THE BENEFIT OF THE YOUTH SECTORS RESIDING IN THEIR RESPECTIVE BARANGAYS

WHEREAS, Section 8 (d) of Republic Act 10742 or the Sangguniang Kabataan Reform Act of 2015 states that the Sangguniang Kabataan should initiate and implement programs and projects designed to promote general welfare, development and empowerment of the youth.

WHEREAS, based on the studies conducted, Mental illness affects 19% of the adult population, 46% of teenagers and 13% of children each year.

WHEREAS, less than half of the abovementioned affected seek treatment due to stigma and discrimination.

WHEREAS, there is an alarming increase of suicide incidents among members of the youth sector at present thus mental health awareness is very important to create time and space to raise conversation, eliminate misconceptions and encourage those suffering to seek help and support network.

NOW THEREFORE, on motion of **Hon. Mark Jayson D. Jamisola**, duly seconded by **Hon. Nestor J. Baldon**, resolve as it is hereby resolved to respectfully request SK Federation President Honorable Renalene Mae J. Duka and the SK Chairperson of sixty four (64) barangays of Sorsogon City to prioritize the conduct of mental health awareness seminar for the benefit of the youth sectors residing in their respective barangays.
