**WHEREAS**, Presidential Decree No. 491, otherwise known as the Nutrition Act of the Philippines mandated the creation of the National Nutrition Council (NNC) as the highest policymaking and coordinating body on nutrition.

**WHEREAS**, the National Nutrition Council established structural organization from National, Regional, Provincial, City, Municipal and Barangay levels to coordinate the planning implementation and monitoring of nutrition activities in the country.

**WHEREAS**, Sorsogon City Nutrition Council have not been reactivated for years including its organizational composition.
