**RESOLUTION DECLARING VALID BARANGAY ORDINANCE NO. 2021-01, SERIES OF 2021 OF BARANGAY BUENAVISTA, WEST DISTRICT, SORSOGON CITY DATED OCTOBER 17, 2022 IN CONSONANCE WITH MEMORANDUM CIRCULAR NO. 177, SERIES OF 2019 DATED OCTOBER 17, 2019 FROM THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT IN RELATION TO REPUBLIC ACT 11032 OTHERWISE KNOWN AS THE EASE OF DOING BUSINESS AND EFFICIENT GOVERNMENT SERVICE DELIVERY ACT OF 2018"**

**WHEREAS**, the main intent and purpose of Memorandum Circular No. 177, series of 2019 issued by the Department of the Interior and Local Government is to provide guidelines and standard processes in the compliance of Section 11 of RA 11032 which states that Barangay Clearances and permits related to doing business shall be applied, issues and collected at the city/municipality in accordance with the prescribed processing time

of RA 11032, PROVIDED, that the share in the collections shall be remitted to the respective barangays;

**WHEREAS**, series of committee hearings was conducted for this purpose inviting the presence of all barangay chairmen in the territorial jurisdiction of the city spearheaded by the Liga ng mga Barangay as an ex-officio member of the 8<sup>th</sup> City Council;

**WHEREAS**, also stated in the aforementioned memorandum circular that barangays shall enact barangay ordinance authorizing the City Treasurer to collect barangay clearances and permits, thus this compliance by the barangay;

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution declaring valid Barangay Ordinance No. 2021-01, Series Of 2022 Of Barangay Buenavista, West District, Sorsogon City Dated October 17, 2022 in consonance with Memorandum Circular No. 177, Series of 2019 dated October 17, 2019 from the Department of the Interior and Local Government in relation to Republic Act 11032 otherwise known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018";

**NOW THEREFORE**, on motion of **City Councilor Angelu Magda P. Ravanilla** duly seconded by **City Councilor Mark Jayson D.
