(Unanimously Proposed)

**RESOLUTION RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR, SORSOGON CITY TO ENJOIN MR. ARNEL ANCHINGES, HEAD SK3 TO REFRAIN FROM NOT ALLOWING TRICYCLE FOR HIRE FROM PICKING UP PASSENGERS WITHIN THE PREMISES OF SM SORSOGON CITY IN THE ABSENCE OF AN APPROPRIATE LOCAL ORDINANCE.**

**WHEREAS**, among the agenda discussed during the November 15, 2022 Regular Session of the 8<sup>th</sup> City Council was the letter from Mr. Jose Corral, President, FASTOD addressed to the Hon. Ma. Ester E. Hamor, City Mayor and copies of the same was duly furnished to the Hon. Mark Eric C. Dioneda, City Vice-Mayor and the Hon. Danilo A. Deladia, Chairman of the Committee Transportation and Public Utilities;

**WHEREAS**, among the issues raised in the letter are as follows;

1. That among the 26 Tricycle Associations operating in the territorial jurisdiction of the City of Sorsogon, SCIKWA, SOTRIDA and PTODA are the only Tricycle Associations allowed by SK3 to pick up passengers within the premises of SM Sorsogon City;

2. That they are wondering why only the three tricycle associations are allowed to pick up passengers within the premises of SM Sorsogon City considering that all tricycle for hire passed through the tedious process of securing a tricycle franchise and complied with the requirements set forth by the Land Transportation Office

**WHEREAS**, finding the matter to be of utmost exigency, the 8<sup>th</sup> City Council invited and allowed the presence of Mr. Jose Corral, President, FASTOD in order to discuss the matter in plenary and open session;

**WHEREAS**, after due deliberation on the matter, hereunder are the collective and unanimous findings of the 8<sup>th</sup> City Council;

1. That indeed, there is an existing Transportation Code passed and approved by the previous city council, however, no provisions thereof that states that only the three (3) aforementioned tricycle associations are allowed from picking up passengers since the said ordinance was approved way back prior to the opening and operations of SM Sorsogon City;
2. That following the principle of fair play and in the absence of a relevant local ordinance wherein only the three aforementioned associations are allowed to pick up passengers, the 8<sup>th</sup> City Council are of the opinion to allow other associations to pick up passengers at SM Premises provided that only tricycle for hire with passengers going to SM Sorsogon City are allowed to pick up passengers and in no case that they be allowed to park or stay in the premises of SM Sorsogon City;
3. That it would be inconvenient on the part of passengers coming from SM Sorsogon City and SITEX in case they would not be allowed to be conveyed to their destination and the driver maybe charged of "refusal to convey passengers"
4. That the herein findings of the 8<sup>th</sup> City Council during the plenary and in open session are in consonance with Section 16 (General Welfare Clause) of Republic Act 7160 otherwise known as the Local Government Code of 1991;

**WHEREAS**, foregoing premises considered, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution respectfully requesting the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enjoin Mr. Arnel Anchinges, Head SK3 to refrain from not allowing Tricycle for Hire from picking up passengers within the premises of SM Sorsogon City in the absence of an appropriate local ordinance.;

**NOW THEREFORE**, on unanimous accord, resolve as it is hereby resolved to respectfully request the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City to enjoin Mr. Arnel Anchinges, Head SK3 to refrain from not allowing Tricycle for Hire from picking up passengers within the premises of SM Sorsogon City in the absence of an appropriate local ordinance;

**RESOLVED FURTHER**, that copies of this resolution be furnished to Mr. Arnel Anchinges, Head, SK3 for his information and guidance.
