RESOLUTION REITERATING THE REQUEST TO THE MANAGEMENT OF SM CITY – SORSOGON TO PROVIDE FREE OF CHARGE MOVIE TREAT TO PERSONS WITH DISABILITIES (PWDs) AND SENIOR CITIZENS OF THE CITY OF SORSOGON DURING THEIR BIRTHDAYS

WHEREAS, on April 15, 2022, the Sangguniang Panlungsod has passed and approved Resolution No. 161, Series of 2022 respectfully requesting the management of SM City – Sorsogon to provide free of charge movie treat to PWDs and senior citizens of the City of Sorsogon during their birthdays;

WHEREAS, Article XV Section 4 of the Philippines Constitution declared that it is the policy of the State to promote a just and dynamic social order for the improvement of the total well-being of the elderly and their full participation in society, considering that senior citizens are integral part of Philippines society;

WHEREAS, to support the fundamental law of the land, the Philippine Congress enacted Republic Act 7432, as amended, or An Act to maximize the Contribution of Senior Citizens to Nation Building, Grant Benefits and Special Privileges and for Other Purposes;

WHEREAS, it is a declared policy of the city government of Sorsogon to give full support to the improvement of wellbeing and integration into the mainstream of the society of senior citizens and PWDs;

WHEREAS, as part of its corporate social responsibility, SM City-Sorsogon is hereby requested to provide free of charge movie treat to PWDs and senior citizens of the city of Sorsogon during their birthdays;

WHEREAS, it further submitted and thereby request the management of SM City – Sorsogon for their consideration to provide free of charge movie treat to PWDs and senior citizens of the City of Sorsogon during their first cinema experience in the mall and another 10% discount subsequent thereon in addition to the existing and prevailing discounts as mandated by law;

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom; as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, improve public morals, enhance economic prosperity and social justice, maintain peace and order and preserve the comfort and convenience of their inhabitants;

NOW THEREFORE, on motion of **Hon. Jo Abegail C. Dioneda**, duly seconded by **Hon. Mark Jayson D. Jamisola**, resolved as it is hereby resolve to reiterate the request to the management of SM City – Sorsogon to provide free of charge movie treat to Persons with Disabilities (PWDs) and senior citizens of the city of Sorsogon during their birthdays.
