**RESOLUTION CLASSIFYING THE PROPOSED DEVELOPMENT OF AN AGRO-INDUSTRIAL COMPLEX OF CENTURY PACIFIC GROUP, INC. LOCATED AT BARANGAY ABUYOG, EAST DISTRICT SORSOGON CITY AS SPECIAL PROJECT UNDERTAKING OF THE CITY GOVERNMENT OF SORSOGON DEFINED UNDER DEPARTMENT OF AGRARIAN REFORM (DAR) ADMINISTRATIVE ORDER NO. 3-A DATED SEPTEMBER 01, 2021.**

**WHEREAS**, on November 11, 2022, the Hon. Ma. Ester E. Hamor, City Mayor, Sorsogon City wrote a letter addressed to the 8<sup>th</sup> City Council in relation to the Proposed Development of an Agro-Industrial Complex of Century Pacific Group, Inc. located at Barangay Abuyog, East District Sorsogon City;

**WHEREAS**, list of agricultural properties adjacent to each other was also indicated in the letter wherein the aforementioned agro-industrial complex shall be established;

**WHEREAS**, by the passage of this resolution and the corresponding approved ordinance in relation to the reclassification of land from agricultural to industrial use, Century Pacific Food Incorporated's conversion application with the Department of Agrarian Reform (DAR) can now be filed under Special Project Undertaking being an Agro-Industrial Undertaking treated as critically important project in conversion, thus expediting the completion of the development which aims to help the people and economy of Sorsogon;

**WHEREAS**, foregoing premises considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution classifying the Proposed Development of an Agro-Industrial Complex of Century Pacific Group, Inc. located at Barangay Abuyog, East District Sorsogon City as special project undertaking of the City Government of Sorsogon defined under Department of Agrarian Reform (DAR) Administrative Order No. 3-A dated September 01, 2021;
