**RESOLUTION ENACTING AN ORDINANCE RECLASSIFYING FROM AGRICULTURAL USE TO INDUSTRIAL USE PARCELS OF LAND COVERING TCT NO. 083-2022001674 CONSISTING AN AREA OF THREE THOUSAND ONE HUNDRED FIFTY-FOUR SQUARE METERS (3,154 SQ. M), OCT NO. CARP2015000386 WITH AN AREA OF SEVEN THOUSAND SQUARE METERS (7,000 SQ. M) TCT CARP2015000385 CONSISTING AN AREA OF SEVEN THOUSAND SQUARE METERS (7,000 SQ. M) TCT CARP2020000119 WITH AN AREA OF EIGHT THOUSAND SQUARE METERS (8,000 SQ. M) TCT NO. 083-2022001908 WITH AN AREA OF ONE HUNDRED TWENTY-NINE THOUSAND EIGHT HUNDRED FORTY-EIGHT SQUARE METERS (129,848 SQ. M) AND TCT CARP2015000387 CONSISTING AN AREA OF FIFTEEN THOUSAND SQUARE METERS (15,000 SQ. M) ALL LOCATED AT BARANGAY ABUYOG, EAST DISTRICT, SORSOGON CITY.**

**WHEREAS**, the application for the herein reclassification measure was calendared during the October 25, 2022 Regular Session of the 8<sup>th</sup> City Council and was subsequently referred to the Committee on Land Use, Urban Planning and Housing;

**WHEREAS**, in compliance with the provisions under RA 7160, otherwise known as the Local Government Code of 1991, the Committee on Land Use, Urban Planning and Housing conducted its public hearing on November 11, 2022 and recommended that an ordinance to that effect be passed for the reclassification of the aforesaid parcels of land;

**WHEREAS**, reclassification as herein approved implies amendments to the Sorsogon City Zoning Ordinance and its corresponding Comprehensive Land Use Plan;

**WHEREAS**, the herein reclassification should be understood as a prerequisite for the land conversion application before the Department of Agrarian Reform (DAR);

**WHEREAS**, foregoing premise considered and after due deliberation on the matter, the 8<sup>th</sup> City Council deemed it necessary to pass a resolution enacting an Ordinance Reclassifying from Agricultural Use to Industrial Use parcels of land covering TCT No. 083-2022001674 consisting an area of Three Thousand One Hundred Fifty-Four square meters (3,154 sq. m), OCT No. CARP2015000386 with an area of Seven Thousand square meters (7,000 sq. m) TCT CARP2015000385 consisting an area of Seven Thousand square meters (7,000 sq. m) TCT CARP2020000119 with an area of Eight Thousand square meters (8,000 sq. m) TCT No. 083-2022001908 with an area of One Hundred Twenty-Nine Thousand Eight Hundred Forty-Eight square meters (129,848 sq. m) and TCT CARP2015000387 consisting an area of Fifteen Thousand square meters (15,000 sq. m) all located at Barangay Abuyog, East District, Sorsogon City;

**NOW THEREFORE**, on motion of **Hon. Nestor J. Baldon**, duly seconded by **Hon. Bryan J. Pingul**, resolved as it is hereby done to enact an ordinance Reclassifying from Agricultural Use to Industrial Use parcels of land covering TCT No. 083-2022001674 consisting an area of Three Thousand One Hundred Fifty-Four square meters (3,154 sq. m), OCT No. CARP2015000386 with an area of Seven Thousand square meters (7,000 sq. m) TCT CARP2015000385 consisting an area of Seven Thousand square meters (7,000 sq. m) TCT CARP2020000119 with an area of Eight Thousand square meters (8,000 sq. m) TCT No. 083-2022001908 with an area of One Hundred Twenty-Nine Thousand Eight Hundred Forty-Eight square meters (129,848 sq. m) and TCT CARP2015000387 consisting an area of Fifteen Thousand square meters (15,000 sq. m) all located at Barangay Abuyog, East District, Sorsogon City.

## *City Ordinance No. 015, Series of 2022*

**AN ORDINANCE RECLASSIFYING FROM AGRICULTURAL USE TO INDUSTRIAL USE PARCELS OF LAND COVERING TCT NO. 083-2022001674 CONSISTING AN AREA OF THREE THOUSAND ONE HUNDRED FIFTY-FOUR SQUARE METERS (3,154 SQ. M), OCT NO. CARP2015000386 WITH AN AREA OF SEVEN THOUSAND SQUARE METERS (7,000 SQ. M) TCT CARP2015000385 CONSISTING AN AREA OF SEVEN THOUSAND SQUARE METERS (7,000 SQ. M) TCT CARP2020000119 WITH AN AREA OF EIGHT THOUSAND SQUARE METERS (8,000 SQ. M) TCT NO. 083-2022001908 WITH AN AREA OF ONE HUNDRED TWENTY-NINE THOUSAND EIGHT HUNDRED FORTY-EIGHT SQUARE METERS (129,438 SQ. M) AND TCT CARP2015000387 CONSISTING AN AREA OF FIFTEEN THOUSAND SQUARE METERS (15,000 SQ. M) ALL LOCATED AT BARANGAY ABUYOG, EAST DISTRICT, SORSOGON CITY.**

Be it ordained by the Sangguniang Panlungsod in session that:

### **SECTION 1      SCOPE/COVERAGE**

This ordinance shall cover and limited to the reclassification from agricultural to industrial use parcels of land covering TCT No. 083-2022001674 consisting an area of Three Thousand One Hundred Fifty-Four square meters (3,154 sq. m), OCT No. CARP2015000386 with an area of Seven Thousand square meters (7,000 sq. m) TCT CARP2015000385 consisting an area of Seven Thousand square meters (7,000 sq. m) TCT CARP2020000119 with an area of Eight Thousand square meters (8,000 sq. m) TCT No. 083-2022001908 with an area of One Hundred Twenty-Nine Thousand Eight Hundred Forty-Eight square

meters (129,848 sq. m) and TCT CARP2015000387 consisting an area of Fifteen Thousand square meters (15,000 sq. m) all located at Barangay Abuyog, East District, Sorsogon City.

Further, such classification shall be used solely for the purpose as applied/intended for.

**SECTION 2 RECLASSIFICATION CLAUSE**

It is hereby reclassified from agricultural to industrial use parcels of land covering TCT No. 083-2022001674 consisting an area of Three Thousand One Hundred Fifty-Four square meters (3,154 sq. m), OCT No. CARP2015000386 with an area of Seven Thousand square meters (7,000 sq. m) TCT CARP2015000385 consisting an area of Seven Thousand square meters (7,000 sq. m) TCT CARP2020000119 with an area of Eight Thousand square meters (8,000 sq. m) TCT No. 083-2022001908 with an area of One Hundred Twenty-Nine Thousand Eight Hundred Forty-Eight square meters (129,848 sq. m) and TCT CARP2015000387 consisting an area of Fifteen Thousand square meters (15,000 sq. m) all located at Barangay Abuyog, East District, Sorsogon City.

**SECTION 3 AMENDATORY CLAUSE**

Provisions of the City Ordinance No. 27, Series of 2021 otherwise known as the Sorsogon City Zoning Ordinance of 2021 and part of the Official General Land Use Map/Comprehensive Land Use Plan (CLUP) of the City Government of Sorsogon covering the herein mentioned reclassification are hereby deemed amended.

**SECTION 4 REPEALING CLAUSE**

All ordinances, resolutions and regulations, or any part(s) thereof which are inconsistent with any provisions of this ordinance are hereby repealed or modified accordingly.

**SECTION 5 SEPARABILITY CLAUSE**

If for any reason or reasons, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provision hereof which are not affected thereby shall continue to be in full force and effect.

**SECTION 6 EFFECTIVITY**

This ordinance shall take effect after compliance of Section 59 of Republic Act 7160 otherwise known as the Local Government Code of 1991.
