RESOLUTION MOST RESPECTFULLY REQUESTING THE HON. MA. ESTER E. HAMOR, CITY MAYOR SORSOGON CITY THRU ENGR. ROEL D. DOMER OF THE CITY ENGINEERING OFFICE IN CLOSE COORDINATION WITH THE BARANGAY OFFICIALS AND OFFICERS PF THE HOMEOWNERS ASSOCIATION TO ENSURE THE REPAIR AND INSTALLATION OF STREET NAMES WITHIN THE TERRITORIAL JURISDICTION OF SORSOGON CITY.

WHEREAS, it has been a common observation within the territorial jurisdiction in Sorsogon City that most of the street names are no longer visible or readable caused by rust and peeled off paints;

WHEREAS, highly visible street lanes serve a crucial and significant purposes as exigencies arise particularly during emergencies requiring medical attention, rescue

operations of CDRRMO, police assistance in case of disturbances of peace and tranquillity of the community;

WHEREAS, it is likewise requested that street names shall reflect the actual number of households therein based on the official number from concerned government agencies or entity;

WHEREAS, concerned government officials, associations constituents and law enforcers must be vigilant in reporting and apprehending person who vandalize street names to the prejudice of the residents

NOW THEREFORE on motion of incidental motion of **Hon. Angelu Magda P. Ravanilla** duly seconded by **Hon. Bryan J. Pingul**, resolve as it is resolved to most respectfully Request the Hon. Ma. Ester E. Hamor, City Mayor Sorsogon City thru Engr. Roel D. Domer of the City Engineering Office in close coordination with the Barangay Officials and Officers of the Homeowners Association to Ensure the Repair and installation of Street Names within the territorial jurisdiction of Sorsogon City.
